Subject: "Conflict Minerals" declaration

In August of the 2012, American Commission (US Securities and Exchange Commission) issued the definitive regulation (with effective date of application from 13 November 2013) subject to Section 1502 of the Dodd-Frank Wall Street Reform and Consumer Protection Act, relating to inhibiting the use of extracted minerals ("Conflict Minerals") from details areas geographic defined as "Conflict Region" that include there Democratic Republic of Congo (DRC) and surrounding countries.

The intention of the final rule was "to attempt to inhibit the capacity of groups armed of the villages covered ("Conflict Region") from finance the they activities exploiting the conflict minerals trade. Reducing the use of such conflict minerals is aimed at help reduce funding for armed groups contributing to the conflict and, therefore, pressure these groups to end the conflict. The goal of the Congress is to promote peace and security in the countries concerned. " (Security and Exchange Commission, 17 CFR Parts 240 and 249b).

TRAMEC

supports peace and security, opposes all forms of violence and violation of rights civilians and any contamination of the environment due to the extraction and at the sales of minerals from war areas ("Conflict Region") and, therefore, **Tramec** is in full support of this law avoiding the use of minerals materials that are not "Conflict Free" certified. With this declaration we confirm that the products supplied by us do not contain raw materials contrary to the above norm mentioned and issued by the US Security and Exchange Commission.
